The remote curriculum: what is taught to pupils at home

What should my child expect from immediate remote education in the first day or two of pupils being sent home?

We expect all students to follow their timetable and attend lessons according to the timings of the school day

All lessons are delivered via Google Classroom and Go Guardian software is used to provide on-going monitoring and support.

If my child does not have digital or online access at home, how will you support them to access remote education?

We recognise that some pupils may not have suitable online access at home. We take the following approaches to support those pupils to access remote education:

- All students have a chrome book through a scheme run from Year 7. Families are able to purchase a device outright or loan a device through the school
- Heads of Year manage a stock of loan devices for each year group
- We have distributed wireless routers to a number of families and are able to provide further support where necessary
- Parents can notify the school about damage or faults to chrome devices through an online portal. We are able to loan devices to students while repairs are undertaken
- Where there are ongoing issues with connectivity a place in school can be offered to the student
- A member of our ICT support team is in school everyday

How will my child be taught remotely?

We use a combination of the following approaches to teach pupils remotely:

Engagement and feedback

What are your expectations for my child's engagement and the support that we as parents and carers should provide at home?

 Students follow their normal timetable and the regular timings of the school day

How will you check whether my child is engaging with their work and how will I be informed if there are concerns?

- Go Guardian software package is used to monitor student's work. This allows staff to directly interact with a student's desktop. Staff can close inappropriate website/work.
- Class charts software package allows staff to award praise and record where work is not visible.
- Staff contact parents where there are concerns
- Each year group has an academic Head of year who focuses on academic engagement.
- Heads of Year are in regular contact with vulnerable students

How will you assess my child's work and progress?

Feedback can take many forms and may not always mean extensive written comments for individual children. For example, whole-class feedback or quizzes marked automatically via digital platforms are also valid and effective methods, amongst many others. Our approach to feeding back on pupil work is as follows:

- Work can be submitted through Google Classroom and staff are able to give feedback directly onto student work.
- Online software packages such as GCSEPod, have elements that are also used for marking and feedback.
- Staff will use a variety of approaches to feedback. These could include
- We also have Go Guardian software which enables staff and students to communicate directly and gives staff access to student desktops.

Additional support for pupils with particular needs

How will you work with me to help my child who needs additional support from adults at home to access remote education?

We recognise that some pupils, for example some pupils with special educational needs and disabilities (SEND), may not be able to access remote education without support from adults at home. We acknowledge the difficulties this may place on families, and we will work with parents and carers to support those pupils in the following ways:

Support for students with additional needs

- all students with a final EHCP or a draft EHCP, are being offered a full time place in school.
- For those young people who do not wish to take up this place, contact will be made with parents/carers to discuss provision in order to complete a risk assessment as required by the local authority; this will take place by 22nd Jan and will be reviewed as necessary.
- Parents/carers of young people with an EHCP can change their decision to attend/not attend at any time and are asked to contact the school in this instance.
- Most students with additional learning needs will be accessing their learning from home. We are able to offer some on line support via Go Guardian during normal school hours either from a member of the SEN team or from another member of our support staff. You will have been contacted via email if your child has been identified for this support.
